On July 12, 2022, the Arizona Corporation Commission voted to approve a rate change for your utility effective August 1, 2022. Global Water agreed to phase in water rates. New rates will be phased in over two years. Additionally, wastewater rates are decreasing. The following pages provide detailed information on the rate changes and effective dates.

CONSERVE WATER AND RECEIVE A REBATE

You are now eligible to receive a rebate under Global Water's Conservation Rebate Threshold ("CRT") program. If you use less than **6,001** gallons in a billing period you will receive a credit on your bill. The credit is equal to 60% of your current months consumption charge.
